Introduction

This template provides (font size:12, font style: Times New Roman) authors with most of the formatting specifications needed for preparing electronic versions of their papers. The author must fill in the information form under the “SUBMISSION PORTAL” tab at JYEM.org, and upload relevant documents. The Reference List needs to be appeared at the end of your paper and provides the full citations for all the references you have used.[1] Margins are 1 inch on all sides and the font is Times New Roman.

Any Subtitle(s)

Define abbreviations and acronyms the first time they are used in the text, even after they have been defined in the abstract. Do not use abbreviations in the title or heads unless they are unavoidable [2].

You will need to determine whether or not your equation should be typed using either Times New Roman or the Symbol font (please, no other fonts). To create multilevel equations, it may be necessary to treat the equation as a graphic. Equation numbers, within parentheses, are to be flushed right, as in (1), using a right tab stop.

$$x+y+z = 3 \quad (1)$$

Note that the equation is centered using a center tab stop.

Figure captions should be below the figures; table heads should appear above the tables. Insert figures and tables after they are cited in the text.

Figure and Table Labels: Use 10-point Times New Roman for the Figure and TABLE labels. Use words rather than symbols or abbreviations when writing Figure axis labels to avoid confusing the reader.

Although a conclusion may review the main points of the paper, do not replicate the abstract as the conclusion. A conclusion might elaborate on the importance of the work or suggest applications and extensions.
